MAIN PURPOSE AND SCOPE OF THE JOB:

To distribute leaflets house to house which promote membership to the Pilgrims Hospices Lottery to support the work of Pilgrims Hospices.

DUTIES AND KEY RESPONSIBILITIES

A To deliver lightweight leaflets door to door, through each house letterbox in agreed areas near you during daylight hours.

B Keep and maintain an up to record of where distribution has occurred.

C Inform the Lottery office of supply need in good time.

GENERAL RESPONSIBILITIES

Corporate Governance -

The post holder must, at all times, act honestly and openly and comply with relevant corporate governance requirements, employment legislation and standards of business conduct. - Be honest and act with integrity
- Accept responsibility for his/her own work and the performance of the people the post holder manages

- Take responsibility for own learning and development
- In all actions undertaken have regard for the hospices reputation

The post holder is expected to work flexibly to be able to meet the challenges and opportunities of working within Pilgrims Hospices in East Kent.
